### PATRICK LENCIONI

Founder and President, The Table Group; Best-Selling Author

Patrick Lencioni is founder and president of The Table Group, a firm dedicated to providing organizations with ideas, products, and services that improve teamwork, clarity, and employee engagement. Lencioni's passion for organizations and the people who work in them is reflected in his writing, speaking, and executive consulting. He is the author of 12 best-selling books with over 7,000,000 copies sold. He has presented his teachings to audiences at many Fortune 500 companies, including Microsoft, Facebook, and Google. Professor, INSEAD; Best-Selling Author

### PAT GELSINGER

CEO, Intel Corporation

Pat Gelsinger is CEO of Intel Corporation and serves on its board of directors. He spent the first 30 years of his career at Intel, becoming its first chief technology officer, and served as senior vice president and the general manager of the Digital Enterprise Group. He was the lead architect of the 80486 processor, managed the creation of key industry technologies such as USB and Wi-Fi, and played key roles in the Intel® Core™ and Intel® Xeon® processor families, leading to Intel becoming the preeminent microprocessor supplier. Gelsinger then transitioned to new positions as the president and COO at EMC, followed by the CEO of VMware, to later rejoin Intel in 2021 in his current role. In 2019, Glassdoor ranked him as the best CEO in America through an annual survey. He holds eight patents in the areas of VLSI design, computer architecture and communications, is an IEEE Fellow, and serves as a member of the National Security Telecommunications Advisory Committee.



### FRANCESCA GINO

Professor, Harvard Business School; Best-Selling Author

Francesca Gino is an award-winning researcher and teacher, and a tenured professor at Harvard Business School. She is the best-selling author of *Rebel Talent: Why It Pays To Break The Rules At Work and In Life*. Her consulting and speaking clients include Bacardi, Akamai, Disney, Ferrari, Goldman Sachs, Honeywell, Microsoft, Novartis, P&G, and the U.S. Air Force, Army, and Navy. Anita Elberse is the Lincoln Filene Professor of Business Administration at Harvard Business School.
